

**MINUTES OF THE REGULAR MEETING
OF THE EXETER TOWNSHIP BOARD OF SUPERVISORS
MONDAY MAY 2, 2022 AT 7:00 PM**

The chairman of the board, Supervisor Nancy Redmond, called the meeting to order at approximately 7:00 PM. In the absence of the Board Secretary, the solicitor, Attorney Gene Molino, served as acting secretary. In addition to the Chairman, Supervisors Fetch, Kreseski, Pendolphia, and Felker were present.

There was a motion to amend the Agenda to add Resolution needed for supporting the PA Commission for the U.S. Quincentennial under new business. Motion by Fetch seconded by Kreseski. Vote – All yes

The minutes of the Regular meeting held on April 4, 2022, were read and approved as follows: Motion by Fetch, seconded by Kreseski to approve minutes of the April Regular Meeting. Vote – All yes

The treasurer's report was read by the acting secretary. Motion by Fetch seconded by Kreseski to accept the reading of the Treasurer's Report. Vote – All yes.

The monthly bills were reviewed by the Supervisors prior to the meeting. Motion by Kreseski, seconded by Felker to approve and pay the bills. Vote – All yes

The chairman opened the floor to public comment on agenda items only. There were no questions or comments.

The board decided to table the previously discussed Comcast Proposal at the April 2022 Regular Township Meeting until they are able to review the formal Proposal. They will further discuss the proposal at the following work session.

Motion to hire Paige Evans as a probationary employee for the position of township secretary/treasurer at the rate of \$18.00 per hour retroactive to April 19th, 2022. In accordance with Exeter Township Personnel Policies Manual adopted pursuant to Resolution 2022-2, the probationary period is for 90 calendar days from the date of hire. Motion by Fetch and seconded by Pendolphia, with all voting in favor of the motion.

The board discussed the Wyoming Area Regional Police Pension Fund Study. Motion by Fetch, seconded by Kreseski to approve payment of \$2,000 to fund study. Vote – All yes

Motion for resolution 2022-4 to approve 30% match for road project grant and elect Paige Evans, assistant secretary treasurer, as the designated person to assist with all executive paperwork. Motion by Kreseski, seconded by Pendolphia. Vote - All yes

Motion to pass Polling Place Agreement by Fetch and seconded by Pendolphia. All in favor of Motion.

Chairman Redmond informed everyone Lisa DeAngelo from State Representative Kaufer's office will be present here at the municipal building on Wednesday May 20th from 9am to 11am.

Motion to pass resolution 2022-3 to support Pennsylvania Commission for the U.S. Semi quincentennial. Motion by Fetch, seconded by Pendolphia. Vote – All yes

Police Report is as follows.

The chairman opened the floor to the public.

Art Becker spoke regarding his appreciation of the flowers provided for the opening of the free library located outside the municipal building.

Linda Pierce commented on the status of the trailer park and asked if the trailer park owner is allowed to move more trailers onto the grounds. Fetch replied and explained it is an issue he is working on and since there is no permit on file, no more trailers should be moved into the trailer park.

Nereo Ninotti complained that there are issues with water runoff between Marcy and Miller Road that is tearing up the roadways. He also commented that the 10-ton weight limit sign for the bridge on Miller Road is unable to be seen until you are already close to the bridge, resulting in truck drivers ignoring the sign and still driving over the bridge. The sign should be moved to the end of the road so weight exceeding trucks can avoid the road completely. Fetch explained the signs are part of the county and will try to contact them to have the issue resolved. Ninotti also explains that there are many trees holding the road up in his area that can fall at any time. Redmond and Fetch advised to speak with Lisa DeAngelo to resolve the issue.

Frank Ryder asked what the status is of the ditch being removed from his property and being put back where it belongs. Pendolphia explained this is an issue that was discussed earlier and is being worked on to be resolved.

There being no further business, it was regularly moved and seconded to adjourn. Motion to adjourn by Fetch then seconded by Kreseski. Vote - All yes. The meeting adjourned at approximately 7:30 p.m.
