Motion to approve a Memorandum of Understanding (MOU) with the police union to reflect an amendment to the Collective Bargaining Agreement (CBA) establishing wage increases for all officers. Motion by Pendolphia, seconded by Fetch with all voting in favor.

Motion to advertise for new full and part time officers pursuant to the adoption of the Memorandum of Understanding. Motion by Fetch, seconded with Kreseski. Vote – All yes

Chairman Redmond did advise there was an Executive Meeting at 6:30 PM, prior to the Township Meeting.

Resident Questions/Comments
