# THE MINUTES OF THE REGULAR MEETING OF EXETER TOWNSHIP BOARD OF SUPERVISORS MONDAY DECEMBER 5, 2022, AT 7:00 PM 

The Exeter Township Board of Supervisors held their monthly meeting on December 5, 2022, at 7:00 PM in the Township Municipal Building. Present were supervisors Pendolphia, Felker, Kreseski, Fetch, and Chairperson Redmond.

Administration

Motion to hire Part-Time Road Department Employee, Bernard Vincavage, at an hourly rate of $\$ 20$ retroactive to November 22, 2022. Motion by Pendolphia, seconded by Fetch. Vote All yes

Motion to hire Full-Time Road Department Employee, Micheal Mikelson, at an hourly rate of $\$ 20$. Motion by Fetch, seconded by Kreseski with all voting in favor.

Chairperson Redmond introduced Ann Mikols, who then explained the Carol Mikols Memorial Scholarship which is eligible to seniors that are residents in Harding and Falls.

Motion to cooperate and coordinate with the Harding Recreation Committee in order to secure grant funding for municipal recreation projects by Fetch, seconded by Pendolphia with all voting in favor.

Motion to accept Officer Darren Bidwell's resignation effective December 1, 2022, by Fetch, seconded by Pendolphia. Vote - All yes

Motion to allow the Harding Recreational Committee use the Municipal Building for the following dates: February 4, 2023; August 5, 2023; September 10, 2023; October 15, 2023. Motion by Pendolphia, seconded by Fetch. Vote - All yes

Chairperson Redmond informed residents the January Reorganization and Township Meeting will be on Tuesday, January $3^{\text {rd }}, 2023$ at 7:00 PM.

Motion to amend agenda to make donation for the Christmas parade by Fetch, seconded by Kreseski with all voting in favor. Motion by Fetch, seconded by Pendolphia to donate $\$ 500$ towards the Christmas Parade taking place on December 17 ${ }^{\text {th }}$. Vote - All yes

Tim Somers - Wilson St Stated he and surrounding neighbors are having issues with another resident's aggressive dogs escaping. Supervisors advised to contact Dog Warden, Jim Spencer.

Tim Deibert - Sunset Dr Complained of trees falling on power lines near his home. Supervisors advised they will have our Road Department look into the issue.
