The Exeter Township Board of Supervisors held their regular monthly meeting on Monday, February 6th, 2023, at 7:00 PM in the Township Municipal Building. Present were Supervisors Pendolphia, Felker, Kreseski, Fetch, and Chairperson Redmond.

Administration

Motion by Kreseski, seconded by Fetch to approve the reading of the minutes with all voting in favor.

Motion by Fetch, seconded by Felker to accept the reading of the Treasurer's Report. Vote – All yes.

The monthly bills were reviewed by the Supervisors prior to the start of the Township Meeting. Motion by Pendolphia, seconded by Kreseski with all voting in favor to accept and pay the bills.

There was an Executive Session prior to the start of the meeting regarding Pending Legal Actions.

Unfinished Business

The Supervisors reviewed the Comcast Proposal provided and agreed to enter a 24-month contract.

Motion to apply for the DCNR Small Communities Grant to help fund a new park by Fetch, seconded by Pendolphia with all voting in favor.

Supervisor Pendolphia and Kreseski will meet with members of the Harding Recreation Committee to further discuss fundraising and improvements for the new park.

New Business

Mt Zion request use of the Municipal Building on April 2nd to host their Annual Easter Egg Hunt, and May16th and November 7th for Election Days. Motion by Fetch, seconded by Pendolphia to approve building use and provide a monetary donation of \$500 for the Easter Egg Hunt. Felker sustained, with all other supervisors voting in favor.

Motion to allow Harding Recreation Committee to use the Municipal Building to host a monthly Children's Free Produce Market which would provide food to children

that are less fortunate run by the Wyoming Area School District. Motion by Pendolphia, seconded by Kreseski with all voting in favor.

Motion by Fetch, seconded by Kreseski to accept Brian Redmond's resignation from the Zoning Hearing Board. Vote – All yes.

Exeter Township is in need of a replacement Zoning Board Member for Mr. Redmond's position and also needs two alternative members on the board.

Reports and Permits

Chief Pace was present to answer resident questions and provide an update on the Wyoming Area Regional Police Department.

There were no Zoning, Building, or Sewage permits provided.

Chairperson Redmond addressed false rumors circulating regarding the Regional Police Department.

Resident Questions/Comments

Bob Warbowski – Questioned when the Hastie Lane project will begin and advised he is having issues with water destroying his blacktop. Supervisor Pendolphia advised he will coordinate with the Road Department Foreman to come view the issue.

Art Becker – Thanked the supervisors on behalf of the Harding Recreation Committee for the use of the Municipal Building to host the First Annual Harding Winterfest.
