

**THE MINUTES OF THE REGULAR MEETING  
OF THE EXETER TOWNSHIP BOARD OF SUPERVISORS  
MONDAY, JULY 3<sup>RD</sup>, 2023, AT 7:00 PM**

The Exeter Township Board of supervisors held their regular monthly meeting on Monday, July 3<sup>rd</sup>, 2023, at 7:00 PM in the Township Municipal Building. Present were supervisors Pendolphia, Felker, Kreseski, Fetch and Chairperson Redmond, along with Attorney Molino and the Secretary.

**Administration**

Motion by Kreseski, seconded by Pendolphia to approve the reading of the Minutes with Chairperson Redmond and Supervisor Felker voting in favor. Fetch abstained due to his absence from the previous meeting.

Motion by Fetch, seconded by Felker to accept the Treasurer's Report. Vote – All yes

The Monthly bills were reviewed by the Supervisors prior to the start of the meeting. Motion by Fetch, seconded by Pendolphia with all in favor to approve and pay the bills.

Residents were informed there were executive sessions held on June 19<sup>th</sup> regarding personnel and July 3<sup>rd</sup>, 2023, regarding Legal Matters.

There were no comments from the floor on Agenda Items.

**New Business**

Motion to hire John Horn as a Season Road Department Machine Operator at the rate of \$20 per hour by Fetch, seconded by Kreseski. Vote – All yes.

Motion to hire Samantha Manning as a Road Department Drive/Operator at \$20 an hour by Fetch, seconded by Felker with all voting in favor.

Motion to apply for the Multi Modal Transportation Grant and adopt the Multi Modal Transportation Grant Resolution 2023-2. Motion by Kreseski, seconded by Pendolphia. Vote – All yes.

**Reports**

Chief Turner was present to answer resident questions and provide a police report.

There were a total of 40 police calls in the month of June.

There were 3 sewage reports for June.

Chairperson Redmond discussed a Broadband survey released that residents could fill out to express any issues they have with Broadband and providers in the area.

Chairperson Redmond also advised a recent PSATS (Pennsylvania State Association of Township Supervisors) Bulletin discussed residents appreciate getting reports from Fire Companies and Ambulances of the Town and recommended our Township start providing such reports.
