ADMINISTRATION

The Exeter Township Board of Supervisors held their regular monthly meeting on Monday, November 2nd, 2023, at 7:00 PM in the Township Municipal Building. Present were Supervisors Pendolphia, Felker, Fetch, and Chairperson Redmond along with Attorney Molino and the secretary. Supervisor Kreseski was absent.

Motion by Felker, seconded by Fetch to approve the reading of the minutes with all voting in favor.

Motion for Supervisor Pendolphia to rebuild the Little League Baseball Field located behind the Municipal Building to dedicate in honor of his grandfather, John H. Hyzenski. Supervisor Pendolphia will be re-edging the infield, installing new bases if needed, adding new mesh to the backstop, installing new Diamond-Tex to the infield, and provide five grass treatments on the outfield (broadleaf application, fertilizer application, grub application, lime application, and overseeding/aerating). Motion by Fetch, Seconded by Felker. Vote – all yes.
