

**THE MINUTES OF THE REGULAR MEETING  
OF THE EXETER TOWNSHIP BOARD OF SUPERVISORS  
MONDAY, APRIL 1<sup>ST</sup>, 2024, AT 7:00 PM**

**ADMINISTRATION**

The Exeter Township Board of Supervisors held their regular monthly meeting on Monday, March 4<sup>th</sup>, 2024, at 7:00 PM in the Township Municipal Building. Present were Supervisors Pendolphia, Kreseski, Fetch, and Chairperson Redmond along with Attorney Molino. Absent was Supervisor Felker and the secretary.

Motion by Kreseski, seconded by Pendolphia to approve the reading of the regular meeting minutes with all voting in favor.

Motion by Kreseski, seconded by Pendolphia to accept the reading of the Treasurer's Report. Vote – All yes.

Motion for the Horizon Community Water Association to use the Township Municipal Building to hold a member meeting on Sunday April 14, 2024. Motion by Fetch, seconded by Kreseski. Vote – All yes.

Motion to hire Gilbert Dominick as a Truck Drive/Laborer for the Exeter Township Road Department by Fetch, seconded by Pendolphia with all voting in favor.
