ADMINISTRATION

The Exeter Township Board of Supervisors held their regular monthly meeting on Monday, June 2nd, 2025, at 7:00 PM in the Township Municipal Building. Present were Supervisors Fetch, Pendolphia, Felker, Attorney Molino and Secretary Sejas.
