

**THE MINUTES OF THE REGULAR MEETING
OF THE EXETER TOWNSHIP BOARD OF SUPERVISORS
MONDAY, DECEMBER 1st 2025, AT 7:00 PM**

ADMINISTRATION

The Exeter Township Board of Supervisors held their regular monthly meeting on Monday, December 1st 2025, at 7:00 PM in the Township Municipal Building. Present were Supervisors Redmond, Fetch, Pendolphia, and Smith along with Attorney Molino and Secretary Sejas.

Motion by Smith, seconded by Pendolphia to approve the reading of the regular meeting minutes. Vote – All yes.

Motion by Fetch, seconded by Smith to accept the reading of the Treasurer's Report with all voting in favor.

The monthly bills were reviewed by the Supervisors prior to the commencement of the meeting. A motion was made by Pendolphia, seconded by Fetch, and unanimously carried to approve and authorize payment of the bills. Supervisor Smith Abstains from Atlas Bill Vote Over Conflict of Interest. NEW BUSINESS
